End User License Agreement for FrogService Subscription [EULA]

Applicable to: Single User [Home] Subscription and School Subscription License.

1. General

The software in all forms [software, data, images, code, text, documents] contained on this CD is the property of Froguts Inc. and only licensed to you for the duration of this agreement [the duration of your actual subscription]. The contents are the intellectual property of Froguts Inc. You may not reproduce the Software/Content unless expression permission has been granted [see below]. We strive to respond in a timely manner to all requests. A sample of the proposed use of the Content may be required to grant permission.

Unmodified utilization/inclusion of Froguts demos or 'screenshots' for non-commercial classroom/educational purposes including: presentations, lectures or handouts is permitted without prior approval as long as Froguts is appropriately cited as the source with "Reproduced with permission of Froguts Inc., <http://www.froguts.com>" and notification of your use is sent to support@froguts.com Permission to reproduce materials for commercial application [e.g. book publishing] must be obtained in writing. 2. Permitted License Use and Restrictions

SCHOOL:

This License allows you to install [copy onto hard drive or run from CD] and use the Software on all computers, workstations, networks, intranets at your school and/or institution. Additionally, copies of the software may be provided to all students, faculty and staff of your institution for home use. Under the End User License Agreement each student, staff and faculty member of the subscribing institution is authorized to have a copy of the CD for use at the institution or at their home. Home use requires local activation using the code from the CD case, global activation XML files may not be

distributed to students. They may not further distribute the CD and must use the institution's activation code to activate home computers. Illegal distribution of the CD or its contents by students, staff or faculty will result in termination of the institutions activation rights and possibly its subscription. Institutions are encouraged to consider these issues when taking advantage of 'home use' as authorized by the EULA. The Froguts Service CD requires a one time web activation for each workstation [school or home] that will run the software. An activation key will be provided with your CD. Your school generally has an unlimited number of activations but you may be required to contact Froguts to request additional free activations upon reaching a preset threshold. There are several ways to manage implementation of our service that mitigate the required level of effort. The use of workstation images or central access to the software are encouraged.
